ACCOMPLISHMENTS: Circle Center Adult Day Services, one of first 100 adult daycare centers in the nation, celebrated 47 years of compassionate and innovative services in May 2023. The Center has long set the standard for care in the entire region and is Virginia's most comprehensive in terms of services, its state-of-the-art facility, and its support and education programs for caregivers.
